- 17/09/98 [redacted] phones Probation and leaves message that they are harbouring files because [redacted] and she have brought it up time and time again and they never suggested taking it to court.
- 22/09/98 Note sayin [redacted] has a lot of the history which would be useful.
- 14/10/98 [redacted] phones, upset, no longer wants to speak to police.
- 16/10/98 [redacted] would like to make a statement
- 19/10/98 [redacted] interviewed, says she was not a victim of [redacted] but [redacted] was.
- 21/10/98 [redacted] and Barbara Gibault [redacted] new [redacted] She says her daughter [redacted] now 10 was fathered by [redacted] Early complaint witnesses are named.
- 21/10/98 Offence report of sexual abuse on [redacted] from age 10-19
- 29/10/98 [redacted] left message to say she was going to kill herself.
- 02/11/98 [redacted] left message to say [redacted] has children b [redacted] [redacted] and [redacted] the [redacted].
- 03/11/98 [redacted] say [redacted] told he [redacted] made her [redacted] and put the dog on her, he would [redacted] er two or three times a night and she was so tired she fell asleep at school.

- 19/11/98 DI Faudemer makes arrangements to show the full suicide note with support in place.

- 01/12/98 Th [redacted] complain [redacted] s threatening them.
- 04/12/98 Irish male leaves threatening message for [redacted]
- 04/12/98 Note from DC Shearer outlining reasons for delays in investigation.
- 10/12/98 [redacted] has gone to [redacted] for Christmas she wants to see the suicide ter Christmas
- 14/12/98 Viscount Peter De Gruchy phone PC Brenda Slater, [redacted] is asking for the note.

- 16/12/98 [REDACTED] is interviewed about the threatening phone calls, admits making them and makes allegations of abuse.
- 16/12/98 DI Faudemer writes to [REDACTED] to say she can see the note.
- 18/12/98 customs asked to keep an eye on [REDACTED] post for porn.
- 18/12/98 Officers involved in the 1991 sudden death enquiry are spoken to re CP aspect being considered at the time. One of thought it had been possibly by CID but was not pursued because it was historic.
- Ins Morgan CPT a [REDACTED] Dorothy Ingliss from Children's service had supplied info re [REDACTED] having child porn.
- No [REDACTED] by DC Shearer saying hey need a full profile [REDACTED] and [REDACTED] families.
- 09/02/99 Complaint by [REDACTED] that [REDACTED] had been making abusive phone calls.
- 12/02/99 [REDACTED] phones police asking for suicide note.
- 16/01/99 [REDACTED] writes to Dr Holmes accusing [REDACTED] of [REDACTED] and of [REDACTED] father said he abuse [REDACTED] no [REDACTED] Letter say [REDACTED] abused the [REDACTED] father money to keep quiet about it. She says [REDACTED] child i [REDACTED] She accuses the doctor of protecting him knowing that he is a paedophile.
