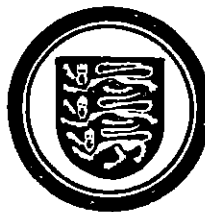

Explanatory Note.

The purpose of this Bill is to make minor amendments to the Nursing Homes (Registration) (Jersey) Law, 1950 to enable registration fees to be amended by Order instead of Regulations and to remove the restrictions on the maximum amounts of fines.

THE STATES, subject to the sanction of Her Most
Excellent Majesty in Council, have adopted the following
Law:-

ARTICLE 1.

In Article 1 of the Nursing Homes (Registration)
(Jersey) Law, 1950, as amended¹ (hereinafter referred to as
"the principal Law") for sub-paragraph (b) in the definition of
"nursing home" there shall be substituted the following
sub-paragraph -

"(b) a mental nursing home within the meaning of the
Mental Health (Jersey) Law, 1969, as amended;"

ARTICLE 2.

In paragraph (1) of Article 2 of the principal Law² -

(a) the words "not exceeding fifty pounds sterling"
shall be deleted where they occur twice;

- (b) for the words "imprisonment and such fine" there shall be substituted the words "imprisonment and a fine".

ARTICLE 3.

Article 2A of the principal Law³ shall be repealed.

ARTICLE 4.

In Article 5 of the principal Law⁴ for paragraphs (2), (3) and (4) there shall be substituted the following paragraphs -

"(2) If any person acts in contravention of or fails to comply with the provisions of any order made under paragraph (1) of this Article, he shall be guilty of an offence against this Law.

(3) The Committee may by order prescribe the fee payable under paragraph (2) of Article 2 of this Law.

(4) The Subordinate Legislation (Jersey) Law, 1960 shall apply to orders made under this Law."

ARTICLE 5.

In Article 9 of the principal Law⁵ the words "not exceeding five pounds sterling" and the words "not exceeding two pounds sterling" shall be deleted.

ARTICLE 6.

(1) This Law may be cited as the Nursing Homes (Registration) (Amendment No. 3) (Jersey) Law, 198 .

(2) This Law shall come into force on such day as the States may by Act appoint and different days may be appointed for different purposes.
